ABSTRACT

The present case under analysis has as its first postulatory procedural act the lawsuit filed on pages No. 29 to pages No. 42 dated September 7, 2012, in the ordinary labor proceeding before the Labor Judge of the Cusco judicial district, through which the plaintiff Julián Huamani Lima, making effective the right of action and the protection of Art. VI of the C.C. P.T. requests Payment of Remunerations pursuant to the Permanent Laborer's Charge and Payment of Non-Remunerative Concepts pursuant to the Permanent Laborer's Charge. According to the lawsuit, the plaintiff is directed against the Provincial Municipality of Cusco represented by its owner; Econ. Luís Arturo Flórez García and with a summons from its Municipal Public Prosecutor's Office.
